Dear Valued Customer,

We are pleased to inform you that Seanav Marine values your business and is currently offering a Shore Based Maintenance (SBM) contract in compliance with Regulation IV/15.7 of the 1974 SOLAS Convention, as amended by the 1988 GMDSS Conference.

In order to assist you with your SBM requirements, we would like to provide some important details. The GMDSS certificate is priced at \$100.00 and remains valid for a period of 5 years. By default, we will send you an electronic copy of the certificate via email, while the original certificate and the Agreement will be sent to you through regular mail, unless you request otherwise.

For the renewal of a previously issued certificate, we will apply the current SBM fee. It is important to note that any changes in the vessel(s)'s name, flag, or owner/management company will render the certificate invalid. Therefore, we kindly request that you promptly notify us of such changes to ensure the issuance of a new certificate in a timely manner.


Please be aware that the process of issuing the certificate may take approximately three to four business days. We appreciate your understanding in this regard.
